Please Note: CCHSA Membership covers the nominated person only under a single or joint membership for insurance and entitles one vote per membership only at CCHSA meetings.

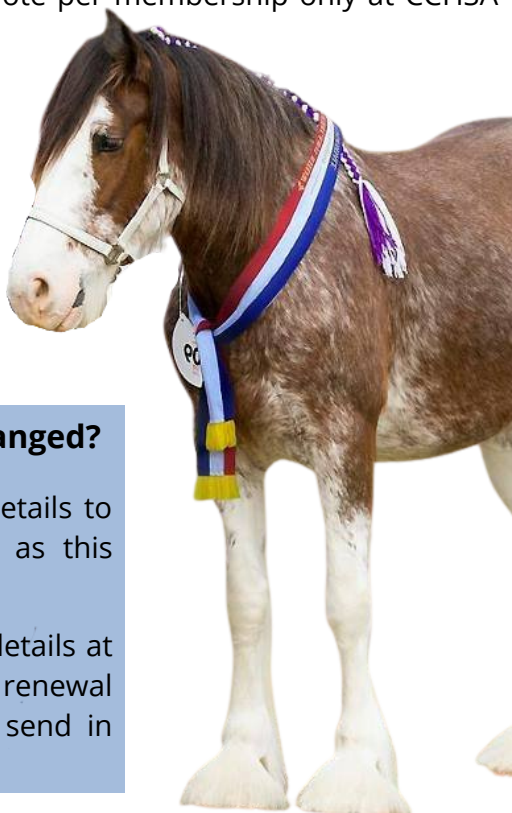
## Would you like a membership card?

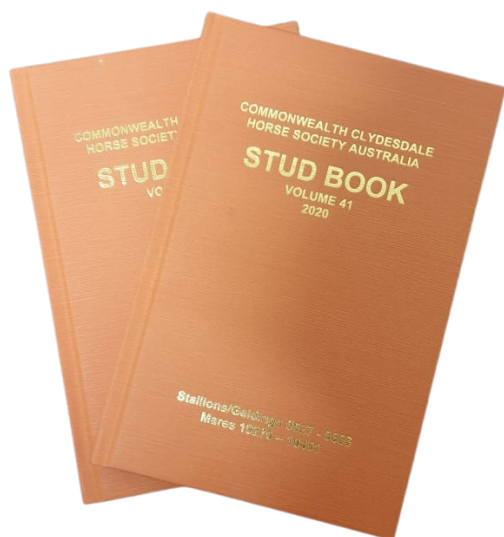


## Fees & Charges - Increase to fees as of 1st July 2022

# Registration Documentation

## **ORIGINAL DOCUMENTS**

It is evident that original registration papers, service certificates or any other relevant documentation is not being submitted to enable completion of registrations or transfers to new owners.

The Federal office **will not** process any registrations, transfers or death of horses unless the **original certificate** is supplied along with the required payment and signed by the current registered owner of the horse.

## **TRANSFERS**

The transfer of a horse is on the back of the registration certificate. Please ensure all relevant details including a contact number or email are completed, and the form must be signed by the previous owner and returned with the appropriate fee. I encourage the current registered owner to return the certificate with the fee to ensure the transfer proceeds smoothly.

PLEASE NOTE: It is the RESPONSIBILITY of the CURRENT OWNER to PAY the transfer fees of ownership to the new owner unless arranged by mutual agreement for the new owner to pay the transfer fees.

If a non-member has purchased a registered horse the Certificate of Registration will be forwarded to the owner, but it is desired the non-member completes, signs and returns a Membership form, so that the office has a record on file of the non-member's signature for any future transfer/death of the horse. A non-member is written to explaining this process, offering them a complimentary membership until the end of the current financial year. Please note: If you are a Financial Member transferring a horse to a non-member or another financial Member the fee is \$30 as of the 1st July.

## **LEASES**

There is also provision on the back of a the registration certificate to record a lease. The process is similar to that of a transfer and the transfer fee is applicable. Termination of a lease is not recorded automatically. When a lease ends, the office should be formally notified by sending back the registration certificate with the owner details and fee. This process needs to be followed for accurate recording and also a formal agreement between both both parties.

## **REGISTRATIONS**

Photographic evidence supporting an application for registration is accepted which can be helpful to determine markings if the breeder is unsure of how to describe the markings. The Society still requires the sketch to be shaded in and the Markings/Colour description provided and signed by the breeder.

## **BRANDING**

As per the CCHSA Stud Book Entry Regulations all horses born after 1st August 1982 MUST BE BRANDED. Please ensure your horse is branded before it is 12 months old, or prior to being sold. Unbranded horses transferring to new owners is not permitted as the breeder signs the registration application verifying the details provided for the horse.

## **SERVICE CERTIFICATES**

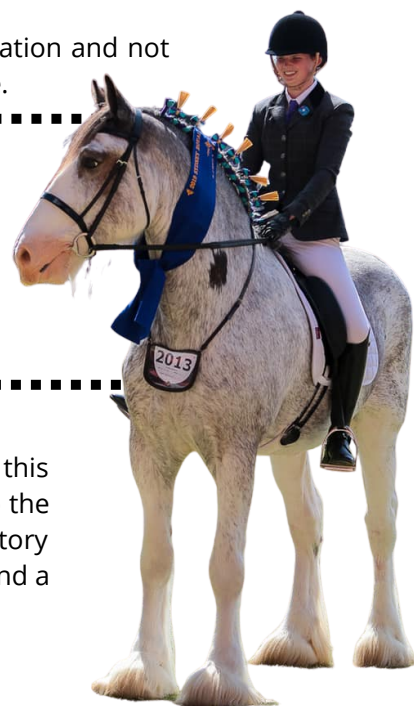
Service Certificates where applicable must be submitted with the application of registration and not sent separately. The application will not be processed unless the application is complete.

## **HORSE DEREGISTRATION**

The Federal Council allows an option of deregistering a horse and this can be done by providing the original registration certificate with notification to deregister written at the bottom on the back page of the certificate where a death or gelding is recorded. The Society will be printing new registration certificates soon which will have provision for this option on the back where a death or gelded is recorded.

## **DNA TESTING OF MARES**

It is not compulsory to DNA test Mares, but an increasing number of Studs are doing this process. DNA kits can be obtained from the CCHSA Office which are \$90 per kit prior to the end of June or \$100 as of the 1st July. Once testing results are provided by the laboratory and the owner sends in the original registration certificate this information is updated and a new certificate of registration provided.





## Registration Documentation

### **VETERINARY CERTIFICATES OF SOUNDNESS FORMS**

Each Vet form is numbered and will be recorded against a specific stallion and therefore is not transferable for another stallion's use. On the form there is provision for a microchip number to be recorded if found, under current CCHSA rules it is not compulsory to have your horse microchipped.

All Stallions serving mares must have a Veterinary Certificate of Soundness & DNA number attached to their registration before their progeny can be registered. A stallion may be inspected at 2 years of age and prior to 5 years old for a Provisional Certificate. A DNA sample must be taken by the vet at this time and sample kits can be pre purchased from the Federal CCHSA Office. Stallions at 5 years require a further inspection for a Life Certificate. Please note: The provisional inspection is not required if the colt/stallion is not being used for breeding purposes until 5 years of age or over.
